

Shallow Well Pump Installation

Most shallow well pumps are installed in the service area near an air conditioner. We recommend that a dedicated power supply for the shallow well pump be installed to an exterior wall near the pump. This should be done by a licensed electrician. Some exterior electrical supplies are adequate, in which case, we tie into the supply without an electrician. We are only allowed to do exterior wiring. Any interior wiring must be done by a licensed electrician and is not included in our pricing. This information is provided for your convenience and does not exclude code variations. Local codes may vary. Any changes in code requirements may result in price adjustments.

Surface Mounted Pumps

Be aware that surface mounted pumps require draining prior to sub-freezing weather. This service can be provided by us for a minimal fee.

Property Disturbance

We exercise extreme care and caution during the water well installation. However, some minor to moderate impact on existing landscape may be unavoidable. Please be aware that our installation of a shallow well requires the use of heavy equipment and a limited area of land disturbance. Most impact is very temporary and is typically unnoticeable within days of the installation.

Guarantee

We guarantee all work and supplies for one year. This does not cover the damage caused by acts of God, abuse or neglect. Examples of damage excluded by the warranty include freeze damage, lightning strikes, damage due to improper sprinkler programming, or pump run-ons due to user error. We service all of our work after the warranty expires, at reasonable rates. Please do not hesitate to call us for further information.

Permits

Chatham County requires a permit before drilling can begin. The permit can be obtained in about two weeks. Customers in other counties need to determine whether permits are required. Permits must be on site before drilling can begin.
